Doctrine of Education Worksheet

A "Doctrine of Education" is your beliefs about education. In essence, we want to know **why** you choose to home-educate. What is the motivational force behind your efforts? On days when you are struggling, you must be able to follow this statement and remember **why** you are doing this.

Here are some thoughts and challenges:

(Taken from the Elijah catalog). In the lives of the Davis family, who operate the Elijah ministry, they state, "In our own lives, as we began understanding the different influences on education, God challenged us with a host of questions":

- 1. What if we look at education differently?
- 2. What if we start viewing it not as a commodity but as an outworking of the convictions and priorities of our family?
- 3. What if we see it as part of the "equipping of the saints . . . for the work of service?"
- 4. What if we operate under a different set of assumptions than institutional education?
- 5. Assumptions like:
 - a. God has created our particular family unit and given us our specific children because our family has a unique, God-ordained meaning and purpose.
 - b. God has put in our hearts the convictions and values of our family's unique meaning and purpose.
 - c. These convictions and values make up the core of the people we want our children to become.
 - d. Our education of our children reflects these convictions and values.
 - e. God will stay actively involved in the proves for our children's sakes."

The definition of *education* according to Webster's 1828 Dictionary:

"The bringing up, as a child; instruction; formation of manners. Education comprehends all that series of instruction and discipline which is intended to enlighten the understanding, correct the temper, and form the manners and habits of youth, and fit them for usefulness in their future stations. To give children a good education in manners, arts and science, is important; to give them a religious education is indispensable; and an immense responsibility rests of parent and guardians who neglect these duties."

With all of these items to think about, here are several questions that will help you write this:

- 1. What is Education? Some verses to help: John 17:17, Psalm 111:10, Proverbs 9:10, 2 Timothy 3:16, Proverbs 16:16
- 2. What is your family's belief about education? What is its purpose? Proverbs 22:6, Titus 1:9, 1 Peter 3:15, 2 Timothy 2:15
- 3. What do we believe about parental rights and responsibilities concerning education? Proverbs 22:6, Psalm 127:3-5, 2 Timothy 3:15

PARENT MEETINGS, PAPERWORK & FEES DUE

"Parent meetings are informative and provide education and training to help our parents fine-tune their teaching skills. This time will also provide mutual support and encouragement, necessary school business, and activity sign-ups. HSLDA recommends a minimum of four classes a year to inform and educate parents with current academic information. Our Support Group more than satisfies the HSLDA requirement per year. Meetings start promptly at 6:30 PM and will conclude at approximately 8:30 PM. To be considered present, one parent must attend the full meeting. Missing more than two meetings can result in dismissal from Revival Homeschool."

"There will be a \$35.00 late fee per child for any paperwork that is not turned in on time. Paperwork must be turned in at the Parent Meeting; they are due on or before then, or they will be late. If you need an extension, you must fill out the appropriate form and have it approved by the Revival Homeschool Director. The application must be received at least two weeks before the due date for the paperwork."

"A Family's enrollment may be terminated if:

- Tuition is two months overdue, and the school has not been contacted.
- If more than two Parent Meetings are missed.
- Family allows their HSLDA membership to expire.
- If reasonable academic achievements are not being met.
- If all communications by the Revival Homeschool office have failed between the office and parents.
- Paperwork (grades, attendance, progress reports, etc.) are not turned in by the set due dates, and no extension has been filed with the Revival Homeschool Director."

A \$15.00 late fee will occur if monthly tuition is not paid by the 5th of each month.
