_____ Due to the ambiguous political and legal position of private home educating programs, we understand that the school cannot offer legal immunity and is only providing school services to assist parents in the schooling of their children.

_____ We agree to become members of HOME SCHOOL LEGAL DEFENSE ASSOCIATION HSLDA.org

_____ We agree that at least one parent will attend the monthly teacher's meetings. We understand that **more than 1 absence and our family can be dismissed from the program.**

_____ We realize that although the school is keeping our children's records, it is in no way responsible for their actual education and we will not place blame on the PSP for failing that purpose.

_____ We have read the School's Statement of Faith (on our website) and we are in agreement with it. We understand that the Christian faith is the basis of this organization.

_____ We understand that when our children attend school-sponsored activities, the parents are required to attend with their children (K-6) and are responsible for their safety, supervision and abide by the Code of Conduct (found in the Revival Homeschool Handbook).

_____ **We understand that failure to pay tuition for more than two consecutive months without notifying school of extenuating circumstances can result in automatic dismissal.**

_____ **I understand that monthly tuition is due the first of each month and I will be billed a late fee of \$15.00 after the 5th of the month.**

_____ **I am responsible to attend monthly meetings and that if I miss more than 2 I will be assessed a fee of \$25.00 and risk being dropped from the program.**

_____ **I understand that I will be assessed a \$35.00 late fee per child, if paperwork is not turned into Revival Homeschool by set due dates, without a two-week prior notice extension approved and in writing to the Revival Homeschool Office.**

PARENT MEETINGS, PAPERWORK & FEES DUE

"Parent meetings are informative and provide education and training to help our parents fine-tune their teaching skills. This time will also provide mutual support and encouragement, necessary school business, and activity sign-ups. HSLDA recommends a minimum of four classes a year to inform and educate parents with current academic information. Meetings start promptly at 6:30pm and will conclude at approximately 8:30pm. **To be considered present, one parent must attend the full meeting. Missing more than 1 meetings can result in dismissal from REVIVAL HOMESCHOOL."**

"**There will be a \$35.00 late fee per child,** for any paperwork that is not turned in on time. Paperwork must be turned in at the Parent Meeting they are due on or before then, or they will be late. If you need an extension, you must fill out the appropriate form and have it approved by the Director. Application must be received at least two weeks before due date of paperwork."

"A Family's enrollment may be terminated if: • Tuition is two months overdue and school has not been contacted. • If more than 1 Parent Meeting is missed. • Family allows their HSLDA membership to expire. • If reasonable academic achievements are not being met. Revival Homeschool (revised: 8/20/2024) • If all communications by the REVIVAL HOMESCHOOL office have failed between the office and parents. • Paperwork (grades, attendance, etc.) are not turned in by the set due dates and no extension has been filed with Academic Administrator."

A \$15.00 late fee will occur if monthly tuition is not paid by the 5th of each month.

Doctrine of Education Worksheet

A “Doctrine of Education” is basically your beliefs about education. In essence we want to know WHY you are choosing to home educate. What is the motivational force behind your efforts? On days when you are struggling you must be able to go to this statement and remember WHY you are doing this.

Here are some thoughts and challenges:

(Taken from the Elijah catalogue). In the lives of the Davis family, who operate the Elijah ministry, they state, “In our own lives, as we began understanding the different influences on education, God challenged us with a host of questions”:

- A. What if we look at education in a different way?**
- B. What if we start viewing it not as a commodity; but as an outworking of the convictions and priorities of our family?**
- C. What if we see it as part of the “equipping of the saints . . .for the work of service?”**
- D. What if we operate under a different set of assumptions than institutional education?**
- E. Assumptions like:**
 - a. God has created our particular family unit and given us our particular children because our family has a unique, God ordained meaning and purpose.**
 - b. God has put in our hearts the convictions and values that make up our family’s unique meaning and purpose.**
 - c. These convictions and values make up the core of the kind of people we want our children to become.**
 - d. Our education of our children reflects these convictions and values.**
 - e. God will stay actively involved in the process for our children’s sakes.”**

The definition of *education* according to Webster’s 1828 Dictionary:

“The bringing up, as a child; instruction; formation of manners. Education comprehends all that series of instruction and discipline which is intended to enlighten the understanding, correct the temper, and form the manners and habits of youth, and fit them for usefulness in their future stations. To give children a good education in manners, arts and science, is important; to give them a religious education is indispensable; and an immense responsibility rests of parent and guardians who neglect these duties.”
